The quotations received in time will be opened **at 04:00 PM on the same day i.e. on 6th August,2021** at SAMEER-CEM, Chennai - 600 113. The bidders or their representatives, not more than one for each quotation, may be present, if they so desire, at the time opening of Quotations. The cover should be prominently

superscripted with the words "QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE".

3. The vehicles will be available for inspection between **02.00 PM and 04.00PM on 26th & 27th, July,2021.**

4. The Auction of said vehicles will be governed by the following conditions: -

- I. **No offers below the reserve price for respective vehicles shall be entertained.**
- II. The bidders are required to pay Earnest Money as mentioned above for each Staff Car.
- III. GST would be extra as applicable.
- IV. Earnest Money is payable by means of Demand Draft drawn in favour of SAMEER-Centre for Electromagnetics, Chennai - 600 113 (payment by cheque or cash shall not be accepted).
- V. Quotations received without demand draft towards Earnest Money will not be considered and shall be rejected.
- VI. The successful bidder will be required to deposit the bid amount by means of Demand Draft or through NEFT, within two working days of the acceptance of the bid.
- VII. The Earnest Money of the successful bidder will be released only after the deposit of the bid amount. Earnest Money will not be adjusted as bid amount and will be forfeited, if he fails to honour the bid.
